Dear Bone and Joint Decade supporting organisation and friend,

On behalf of the BJD Steering Committee I am pleased to report to you of the latest achievements in regard to the initiative.

Lars Lidgren, Chairman of the Steering Committee

We are now one-third of the way into the Bone and Joint Decade and through our combined efforts we are starting to influence change - a change in awareness – priorities, strategies, education, research funding and much more. We have received signed endorsements from 49 governments. Two journals (<http://www.boneandjointdecade.org/news/articles.html>) have dedicated entire issues to musculoskeletal disorders and the Decade. The Technical Report prepared in conjunction with the WHO was launched on the 27th of October and a strategy for dissemination agreed on during the BJD Network Conference in Berlin.

2003 BJD World Network Conference took place on October 30 – November 2, 2003 in Berlin, Germany. Participants from 48 countries, members of the BJD International Steering Committee (ISC) and patient representatives attended the meeting. The participation of the German Health Minister, Mrs Ulla Schmidt, and Dr Nikolaï Khaltaev from WHO and Dr Brigitte Mohn, from the Bertelsmann Foundation was appreciated. The official opening of the meeting took place in the Daimler-Chrysler atrium. Local hosts for the meeting were Prof Wolfhart Puhl, German NAN Coordinator, and Dr Karsten Dreinhöfer, BJD Director of Development. The BJD major global sponsors for 2003,

Pfizer and Aircast, participated in the meeting on a corporate level.

The main sponsors for the meeting were: Daimler-Chrysler, Zimmer-Centerpulse and Gelita.

At the start of the BJD World Network meeting, 28 patient representatives met to learn about the collaborative work of patient organisations. BJD Spokesperson and Director of Strategic Relations, Amye Leong facilitated the meeting. Armin Kuder, member of the International Steering Committee, provided a brief history of the BJD World Network Meetings, and overview of the role of patient organisations

in the BJD was provided by ISC member, Liana Euller-Ziegler. Sara Martin, BJD Communications Manager and Mr Zachary Sikes, Pfizer Medical Humanities Initiative, provided an introduction to the BJD Musculoskeletal Portal project. Each patient representative gave a brief summary of their organisation's programs in support of the BJD as well as an update on national BJD activities. It was confirmed that an extended meeting of patient representatives will be incorporated into the 2004 BJD meeting.

A **Nordic Walk** in central Berlin followed the opening ceremony. Hundreds of Berliners came out for the chance to participate in the lively event, which was led by two German Olympic skiers and several national ski instructors. Launch of WHO/BJD Technical report, 27 October University of Lund, Sweden

“The Burden of Musculoskeletal Conditions at the Start of the New Millennium” is the result of three years of work that establishes the burden of musculoskeletal conditions around the globe and recommends how it can be monitored. It was undertaken collaboratively between the WHO and the Bone and Joint Decade with an international scientific group of experts and was coordinated by a steering group of Tony Woolf, Kristina Åkesson and Mieke Hazes. We hope that the report will serve to increase the awareness and raise priority of these conditions at all levels. It is published in the WHO Technical Report Series. The Bulletin of the World Health Organization

The Steering Committee (ISC) of the BJD is indebted to the Publications Staff (Ian G. Neil and his colleagues) at the WHO for focusing **Volume 81, number 9** of the Bulletin of the World Health Organization on issues of the BJD written by many members of the ISC.

As Chair of the ISC, Lars Lidgren wrote the lead editorial for the Bulletin, outlining the goals and mission of the BJD that continue to expand as interest in the Decade grow. Papers by George Ehrlich and Edward Harris focus on the continuing problems of osteoarthritis and rheumatoid arthritis, respectively. A major focus of the BJD activities, developing policy, was enhanced by articles providing majestic numbers of those affected by musculoskeletal conditions around the world (Tony Woolf and Bruce Pfleger), concepts of treatment of osteoporosis relevant for the full world's populations (Kristina Åkesson), the challenges of rehabilitation of landmine victims (Nicholas and Wendy Walsh), the continuing challenge world-wide of managing low back pain (George Ehrlich), and some good news about the improved education in schools and medical centers about musculoskeletal diseases (Kristina Åkesson, Karsten Dreinhöfer and Tony Woolf). Dinesh Mohan accentuated a major concern of the BJD - the pandemic of road traffic injuries, and Dick Heinegård and his colleagues linked clinical medicine with basic research by pointing out the burgeoning research effort funded by many

sources that is enhancing our understanding and treatment of musculoskeletal diseases.

BJD Global 24hr eLecture Series

A major highlight of this year's Action Week, on October 15th more than 6,000 people from around the world logged on to the BJD's first-ever 24-hour global eLecture series, accessing talks on the latest research presented by internationally known specialists in the field of musculoskeletal health.

For a 24-hour period starting at 1:00am on the 15th, a different lecture was web cast on the hour every hour. Each online lecture was followed by a 30-minute live Q&A session with the specialist via the BJD web portal discussion boards (<http://www.bjdonline.org>)

Themes for the e-lectures covered a broad range of musculoskeletal issues, ranging from treatment of osteoporosis and osteoarthritis, through to state-of-the-art fracture fixation, and hip arthroplasty. Feedback from participants showed that the educational lectures were particularly useful to trainees and residents, and viewers in economically developing regions who might not normally have the opportunity to attend meetings were these opinion-leaders speak.

This unprecedented event represents a new way of reaching out to researchers, educators and patients involved in the BJD around the world and based on very positive feedback to the event, it has been decided not only to make it a permanent part of Action Week, but also to make the eLectures available in an online Lecture Archive for viewing at a later date. From the corporate side, attendees heard an in-depth description by Mr David Clay, Director in the Pfizer Medical Humanities Initiative, the division of Pfizer, which partners with the BJD on the portal initiative.

From the society side, attendees had the opportunity to present an ePoster of their portals, discussing challenges and successes they have encountered over the past half year, to share best-practices with the group.

From the BJD, Dr Göran Magyar, Executive Director, presented an overview of the new content which has recently been made available to all societies including the BJD MSeC Faculty Recommended Reading List, the eLecture Series, conference coverage of EFORT, EULAR, BOA, to name a few.

During the second half of the meeting society members split into three task groups to focus on finding solutions to technology issues, content ideas, and networking needs. Some of the plans set into motion include upgrading the portal's e-meeting function to include Voice-Over-IP; expanding the Faculty Recommended Reading List to special editions such as Themed Lists, and Year-In-Review lists; and creating 'cutting-edge' eLecture Libraries.

Germany: On October 30th the German Network organized a 1-day press seminar supported by the German Ministry of Health and Social Welfare and the Bertelsmann Foundation. More than 40 journalists and representatives from the 23 member organizations attended that seminar focusing on "joint diseases and prevention". Scientific presentations from experts in the field reporting on new developments as well as reports from patient organizations provided a platform for fruitful discussions and allowed the journalists to collect valuable information and contacts.

Hungary: In a book published by the Hungarian Academy of Sciences about the health status of the country, participants of the Decade wrote the chapter about musculoskeletal diseases.

This third edition of the book Practical Rheumatology was freely distributed to the 6500 general practitioners as an action of the Decade.

The NAN also started a survey studying the treatment and care of knee osteoarthritis patients. The first results were presented on the occasion of the Arthritis Day. During Action Week the most widely watched Hungarian TV channel, Duna TV, screened a 40-minute film about the Decade, including the national aims and efforts. The professionals and patients taking part in the Decade initiated this film, and took active part in its realisation.

The Hungarian Society for Osteoporotic Patients together with the Hungarian Osteoporosis and Osteoarthrology Society the Hungarian National Health Program and the Bone and Joint Decade Foundation organised a Press Conference under the

patronage of the Minister of Health Affairs, Dr. M. Kőkény, titled: “How to prevent the first fracture?”

The Hungarian Lupus Society organised a very successful meeting on the Action Week drawing public attention to the problems of lupus patients.

Formation of the South-Eastern European Regional Council of BJD

Initiated by the **Slovenian NAN**, and Prof. Radko Komadina, a Regional Council of BJD was formed at Portorož, Slovenia on 6 and 7 October. Dr Géza Bálint, NAN Coordinator in Hungary represented the International Steering Committee (ISC) at this meeting. All countries of the region including Albania, Bosnia-Herzegovina, Bulgaria, Croatia, Greece, Hungary, Macedonia, Romania, Serbia-Montenegro, will take part in the Council.

The following common projects were agreed for collaboration work:

- *The status and rehabilitation of the war victim handicapped, including the victims of landmines. That is a sad special issue of the region.*
- *Prevention of road accidents, better and more sufficient treatment, care and rehabilitation of the victims.*
- *Proximal femoral neck fractures: prevalence, diagnosis, treatment, rehabilitation, outcome, and costs.*
- *Cervical neck injuries with neurological deficits*
- *Prevalence, causation, treatment, rehabilitation, outcome*

- *Spinal deformities in children. Prevalence, causation, treatment, rehabilitation, outcome*
- *Co-operation of patient societies*

The group had an informal meeting in Berlin and agreed to develop these projects.
